What does it mean to be a Title I School?

- Being a Title I school means receiving federal funding (Title I dollars) to <u>supplement</u> the school's existing programs. These dollars are used for...
 - Identifying students experiencing academic difficulties and providing timely assistance to help these students meet the State's challenging content standards.
 - Purchasing Supplemental Staff / Programs / Materials / Supplies
 - Conducting Parental Engagement Meetings / Trainings / Activities
 - Recruiting / Hiring / Retaining Quality Teachers
- Being a Title I school also means parental engagement & involvement and parents' rights.

What is the 1% set-aside and how are parents a part of this decision?

1% of Funds for Parental and Family Engagement

Any local education agency, LEA, which exceeds \$500,000 in Title I funds, must allocate 1% of those funds for parental engagement.

LEA simply means our school district.

- As parents and guardians, you all have the right to know and have input into how that 1% of the money is spent.
- This year's 1% is \$2511.30. Some of the items we will purchase are Thursday Folders, Student Planners, Tiger T-shirts, etc.

What is a CIP?

CIP stands for Continuous Improvement Plan. CCMS has a CIP to improve our school and gives us a focus for the year and the following years.
