Pleasant Grove Elementary will:

 - *Utilize Cleburne County School System Pacing Guides to plan lessons for each subject.*
 - *Participate in data meetings and grade level meetings in order to analyze results of student assessments and discuss strategies to address learners' needs.*
 - *Collaborate with Enrichment/Interventionist in order to implement appropriate*
- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:
 - *At the end of the first grading period.*
 - *Beginning of second semester.*
 - *As needed to address an individual child's progress and achievement.*
- 3. Provide parents with frequent reports on their children's progress.**
 - *Specifically, the school will provide reports as follows:*
 - *Mid-term progress reports will be sent home each of the four grading period for grades 1-4.*
 - *Report Cards will be sent home at the end of each grading period.*
 - *Students' weekly graded work will be sent home daily in the Parent/Teacher Communication Folder.*
 - *Students' daily homework will be sent home daily.*
 - *Notes of interest of parents: conduct, grades, need for conference will be included in the Parent/Teacher Communication Folder but not limited to but can include; emails, phone calls, etc.*
 - *Star Math and Star Reading results will be sent home.*

- *Any other State Assessment will be sent home as per the Alabama State Department of Education.*

4. Provide parents reasonable access to staff.

Specifically, staff will be available for consultation with parents as follows:

- *Student Orientation*
- *Daily scheduled planning periods*
- *Scheduled after-school conferences*
- *Open House*
- *Communications via e-mail for parents with Internet access*
- *Written communication*
- *Phone Communication*

5. Provide parents opportunities to volunteer and participate in their child’s class, and to observe classroom activities in line with COVID 19 Guidelines as follows:

- *Attending Field Trips as warranted*
- *Participation in class holiday celebrations*
- *Volunteering to help with art, reading, and/or enrichment activities*
- *Volunteering to help with special events, such as Fall Festival, Field Day, and Family Night*
- *Volunteering to be a reader for Read Across America*

Parent Responsibilities
